#### Treasurer's Report (Appendix II) 6.

Current bank balance just over \$4000 looking much healthier than the \$700 it was in May. This includes the entry fees from the Woodend and West Melton Forest winter series rides with the expenses for West Melton Forest still to be paid. The ride breakdown from Woodend showed a \$632 profit.

While several toilet rental enquiries have been received, so far only rented out once. They are currently stored at Leeches and a minimum of 2 days' notice required for them to be prepped for collection. Encouraging ribbon recycling was raised.

Asking for a gold coin donation for rider sausage sizzle was raised and agreed to be discussed in future by committee.

Ground fees for the ride venues have been sorted, except for the bottle lake permit cost.
